NOTIFICATION

No.D.33011/6/19-HFW (IDSP)/57: In order to facilitate active surveillance, detection and monitoring of case upsurge/outbreak of Covid-19 and other communicable diseases and in the interest of public service, the Governor of Mizoram is pleased to establish a 3-tier Disease Monitoring & Control Room (DMCR) under Integrated Disease Surveillance Programme (IDSP) at State, District and at Facility Level in Mizoram with immediate effect and until further order.

DISEASE MONITORING AND CONTROL ROOM IDSP:

IDSP Control room shall consist of 3 tier structures, State IDSP, District IDSP and facility level control rooms to monitor any disease upsurge/outbreak in the state.

TERMS OF REFERENCE AND STRUCTURE

1. DISEASE MONITORING AND CONTROL ROOM, IDSP AT STATE HEADQUARTER (State Surveillance Unit, IDSP)

- Manpower: 1. State Surveillance Officer, IDSP
 - 2. IDSP Staff

Terms of Reference:

- 1. Monitoring and evaluation of Integrated Health Information platform (IHIP) implementation in the state.
- 2. Surveillance and Monitoring of any disease case upsurge/outbreak in the State.
- 3. Daily/regular collection of disease data from district control room or elsewhere in order to detect upsurge and impending disease outbreak.
- 4. SSU, IDSP shall compile the collected data from districts on daily basis at 5 pm and the same shall be shared to concerned health authorities.
- 5. Monitoring and evaluation of district IDSP control room performances.
- 6. Implementation of public health actions in any disease upsurge/outbreak in coordination with District heath authorities.

2. DISTRICT DISEASE MONITORING AND CONTROL ROOM IDSP (District Surveillance Unit, IDSP) AT EVERY DISTRICTS

- Manpower: 1. Chief Medical Officer
 - 2. District Surveillance Officer (in-charge of IDSP)
 - 3. IDSP staff at districts

Terms of Reference:

- 1. Monitoring and evaluation of Integrated Health Information platform (IHIP) implementation in the district. Any new (disease) case detected should be entered in the IHIP portal on the same day without delay.
- 2. Prompt and regular collection of data from reporting unit under their jurisdiction.
- 3. Daily reporting of any disease case upsurge/outbreak including Nil report to SSU at 4 pm.

Cont.2/-

 Regular monitoring and evaluation of Facility level (reporting units) control room performances.

5. District control room shall collected data from Private hospitals and

laboratories under their jurisdiction.

6. Any upsurge/outbreak/impending outbreak detected shall be informed to State IDSP control room at the earliest so as to operate public health response jointly with SSU or by the district itself after consultation.

3. FACILITY LEVEL DISEASE MONITORING AND CONTROL ROOM IDSP (Facility Surveillance Unit, IDSP) AT PHC, CHC AND SDH

Manpower:

- 1. In-charge Medical Officer
- 2. Pharmacist or Nurse (in-charge of IDSP to be designated by MO)
- 3. Laboratory Technician

Terms of Reference:

- 1. Monitoring and evaluation of Integrated Health Information platform (IHIP) implementation in the facility level. Any new (disease) case detected should be entered in the IHIP portal on the same day without delay.
- 2. Prompt and regular collection of data from reporting unit under their jurisdiction.
- 3. Daily reporting of any disease case upsurge/outbreak including Nil report to DSU at 3:30 pm.
- 4. Regular monitoring and evaluation of reporting units (Main Centre/Sub Centres/ private laboratory etc.) performances.
- 5. Any upsurge/outbreak/impending outbreak detected shall be informed to District IDSP control room at the earliest so as to operate public health response.
