No.D.33012/9/2022-HFW (BMW)/99: Under the power conferred by Rule 10 of the Bio-Medical Waste Management Rules, 2016 as amended in the year 2019, the Governor of Mizoram is pleased to prescribe Annual authorization fee, where authorization is given by the prescribed authority i.e., Mizoram Pollution Control Board to an Occupier/Operator of an institution generating, collecting, receiving, storing, transporting, treating, disposing and/or handling bio-medical waste irrespective of the quantity of bio-medical wastes, in the following manner or as may be prescribed by the Government from time to time. This notification supercedes the Notification No.B.11013/12/200/FST dated 13.11.2003.:-

A. OCCUPIER: 'person having administrative control over the institution and the premises generating bio-medical waste, which includes a hospital, nursing home, clinic, dispensary, veterinary institution, animal house, pathological laboratory, blood bank, health care facility and clinical establishment, irrespective of their system of medicine.'
