(a) The District & Sessions Judge, Aizawl Judicial District who shall be the chairperson of the Board.

(b) Representative of the Deputy Commissioner, Aizawl District.

(c) Two members of whom one shall be a psychiatrist and the other shall be a medical practitioner.

(d) Two members who shall be persons with mental illness or care-givers or persons representing organizations of persons with mental illness or care-givers or non-governmental organizations working in the field of mental health.

Through this letter, I would like to seek your intervention to an important issue of expediting action for a statutorily warranted action on the part of your State/ UT i.e. framing of Rules under the Mental Healthcare Act, 2017, in addition to implementation of other provisions of the Act.

This Ministry has, from time to time, requested State/ UT Governments to take early action for framing of Rules as per Section 121 of the Mental Healthcare Act, 2017. While some of the State Governments have promptly taken action in this regard and submitted Rules for approval of the Central Government, we have yet to hear from your State/ UT regarding progress made in this regard. The Hon'ble Courts and National Human Rights Commission (NHRC), in related cases have expressed concern about the tardy implementation of the Mental Healthcare Act, 2017 and allied Rules.

It may please be noted that compliance to the provisions of the Act needs to be ensured in time bound manner. Therefore, I would again request you to look into the matter personally and arrange to:

submit the draft Rules framed by your State/ UT under the Mental Healthcare Act,
 2017 to this Ministry at the earliest for approval.
