1. Licence Retention chungchangah FDA Circular (No.B.17011/24(B)/17/DHS/DRUGS/108 date 16.10.24) ngaih pawimawh hle tur a ni.
2. Restricted Retail dawrten an zawrh theih bak damdawi an kaw em tih vil ngun tur a ni a, kaw luh tlat an awm chuan Licensing Authority hnenah report tur a ni.
3. General Retail dawr chu pharmacist-in a enkawl em tih vil ngun baw tur a ni. Dawrah pharmacist a awm ngai loh chuan chhui chiana, Licensing Authority hnenah report thuai tur a ni.
4. Licence nei si dawr hawng ngai lo an awm chuan chhui chiana, an dinhmun Licensing Authority hnenah report zel tur a ni.
5. Motor hmanga damdawi zuar (*mobile distributor*)-te vil ngun tur a ni. Hengte hi mobile licence kalphung tur a ni a, dan zawm lo an awm chuan Licensing Authority hnenah report tur a ni :-
  - 1) An district tlanna tur FDA Official-te hnenah an in-report thin tur a ni.
  - 2) Damdawi phurh list leh phurh zat (*checklist*) an keng tur a ni a, licensed dealer/manufacturer atanga an lakna lehkha (*Invoice*) an keng baw tur a ni.
  - 3) Mobile licence atan hian danin *competent person* rawih a phut hran loh avangin, licence neitu chu motor-a damdawi zawrh buaipuitu tur a ni. A licence hmangin midangin damdawi an zuar tur a ni lo.
  - 4) Motor-ah Drug Licence leh Inspection Book (Form-35) a awm ngei tur a ni.
  - 5) Licence-a motor registration number tarlan chauh hman tur a ni a, motor pawnlam bang langsar laiah mobile dawr hming leh tlanna district hming tarlan baw tur a ni.


- 6) Damdawi hralh a nihin mobile licence cash memo pek tur a ni a, memo-ah chuan motor registration number leh tlanna district hming tarlan tel tur a ni.
- 7) Heng damdawi ruih nana hmansual thinte hi an phur tel tur a ni lo :-  
*Alprazolam, Diazepam, Nitrazepam, Tramadol, Zolpidem leh Codeine Based Cough Syrup (CBCS).*
- 8) Cold Storage facility awm lovin temperature hniama dah ngai damdawi an phur tel tur a ni lo.
