(Pharmacist In-Charge nih chungchang)

Damdawi enkawl leh damlo hnena doctor prescription anga damdawi pekchhuah hi pharmacist chanvo leh mawhphurhna a ni a. Damdawi lam dan kan neih chi hrang hrang – The Drugs & Cosmetics Act/Rules, The Pharmacy Act leh Pharmacy Practice Regulations-te chuan mipui himna tur dah pawimawh berin, damdawite chu pharmacist ngeiin emaw, a enpui leh kaihhruaina hnuaiah chauh damlo hnena pekchhuah tur a ti a. Midang khawih ve khapin pharmacy profession an humhalh tlat a ni. Chuvangin, pharmacist-ten an thawhna pharmacy an vil ngunin an enkawl tha hle tur a ni a, heng a hnuaia tarlante hi ngaipawimawhin an zawm tur a ni :-

1. Mizoram State Pharmacy Council (MSPC) atanga Registration Certificate hmangin hmun khat (*one establishment*) aia tamah pharmacy profession practice theih a ni lo.
2. *Qualified person In-Charge*-ten an thawhna pharmacy hunpuma thutchilhin an enkawl tur a ni a, MSPC-in Pharmacy Supervision Notebook a siamah wawi 4 tal observation thlakhatah an ziaak lut thin tur a ni.
3. D&C Rules hnuaia Schedule H-1 damdawi hralh a nihin hralhna record/register a hranga vawn tur a ni a, chhuizui theih turin kimchang taka ziah tur a ni.
4. Schedule H-1 zinga damdawi ruih theih (*habit forming drugs*) te khawtlangah hman sual a hluar zel loh nan lak luh leh hralhchhuahah fimkhur hle tur a ni.
