Drugs & Cosmetics Rules, 1945 Rule 65(9)(a)-na chuan Schedule H, H(1) and X hnuaia damdawi awmte chu doctor chawhna lehkha neite hnenah chauh hralh tur a ni a ti a. Schedule X damdawite chu doctorin a chawhin lehkha pahnih damlo hnenah a pe ang a, damdawi hralhtu chuan copy khat chu kum hnih chung a vawng tha ang a ti a ni.

State Licensing Authority, Directorate of Health Services, Aizawl chuan damdawi hmansual theih kawh leh hralh thuah a khat tawkin circular a chhuah thin a. 
