**CIRCULAR**  
*(Licence Dilna Form pekchhuah chungchang)*

Online National Drug Licensing System (NDLS), 'Sugam Portal' chu India ram puma hman tura tih a nih angin State tam takah hman tan a ni tawh a, Mizoramah pawh hman theih thuai beisei a ni.

Drug Licence hi Drugs & Cosmetics Act, 1940 & Rules, 1945 hnuaiia pek a ni a. Dan chuan licence chu Regd.Pharmacist hnenah emaw, damdawi dawr enkawl tura Regd.Pharmacist ruait hnenah emaw chauh pek tur a ti a ni. Regd.Pharmacist phut a nih chhan chu damlo leh mipui himna tur atana tih a ni a. Damdawi chungchanga fimkhurna tur pawimawh awm apiang hriattir paha Pharmacist ngeiin damlo hnena damdawi a pekchhuah theih nan leh, damdawi enkawl tura damdawi chin hria a nih vang a ni. Hetiang hi danin a phut chu a ni :-

- 1) **Rule 65(2) of D&C Rules, 1945 :** Doctor damdawi chawh reng reng chu Regd.Pharmacist-in emaw, a enpuina hnuaiia emaw chauh damlo hnena pekchhuah tur a ni (*any drug supplied on the prescription of a Regd.Medical Practitioner shall be affected only by or under the personal supervision of a Regd.Pharmacist*)
- 2) **Section 42 of the Pharmacy Act, 1948 :** Regd.Pharmacist chauh lo chuan midang tumahin doctor damdawi chawh an pechhuak tur a ni lo (*no person other than a Regd.Pharmacist shall compound, prepare, mix, or dispense any medicine on the prescription of a Medical Practitioner*)

Damdawi dawr rintlak leh him kan neih theih nan khauh zawka licence pekchhuah hi kalpui tum a ni a. Thinglang khua damdawi dawr awm mumal lohnate erawh dan anga an kawl theih tur chin thlir chungin ngaiantuah sak theih an ni ang. Chutichuan, Sugam Portal hman theih a nih hma atan Mizorama drug licence dil dan tur chu hetiang hi a ni ang:-

1. Licence dilna hun bik hawn a awm lo vang a, State Licensing Authority, DHS (FDA Wing) hriatpuina hnuaiia application form district office-in a pe chhuak thin ang.
2. Registered Pharmacist, mahni hminga licence dil duhte erawh licence atana '*qualified person*' an nih avangin district office-in application form a pe chhuak nghal thei ang.
