CIRCULAR

(District Hospital, CHC leh PHC-a Pharmacy
hawn chungchanga hriattur pawimawh)

Department lama thawkta indaih loh avangin Mizoram damdawiin hrang hrangah sawrkar enkawl tura pharmacy hawn a remchang rih lo niin a lang a. Damdawiinah pharmacy hi mamawh a nih si avangin Department hotute thuchhuak angin Hospital Pharmacy (Canteen) chu pawn lam mite luah tura Tender System-a kalpui rih tur a ni. Hemi chungchangah hian heng a hnuia tarlante hi ngaihpawimawh atan Mizoram FDA chuan a chhawp chhuak a ni :-

1. Hospital Pharmacy (*Canteen*) chu **100% prescription** dawnna hmun a nih avangin **pharmacist-in** full time-a thutchilha a enkawl ngei a ngai a. *Bidder-te chhanna san leh san loh emaw, discount an pek theih dan etc. a pawimawh rualin, pharmacist thutchilh leh enkawl ngei a ni dawn em tih hi ngaih pawimawh hle ni se.* Dan chuan hetiang hian a sawi a ni :-
 - a) **Section 42 of Pharmacy Act, 1948** : *No person other than a regd. pharmacist shall compound, prepare, mix, or dispense any medicine on the prescription of a medical practitioner.*
 - b) **Regulation 3.4 (a) of Pharmacy Practice Regulation, 2015** : *The owner of a pharmacy business shall appoint a regd. pharmacist, otherwise the owner shall be deemed contravening section 42 of Pharmacy Act.*
 - c) **Regulation 9.1(a) of Pharmacy Practice Regulation, 2015** : *Actual dispensing of drugs to patients shall only be performed by the regd. pharmacist after due verification of the prescription filled by others.*
 - d) **Rule 65(2) of the Drugs Rules, 1945** : *Any drug supplied on the prescription of a regd. medical practitioner shall be affected only by or under the personal supervision of a registered pharmacist.*
2. Hospital Pharmacy (Canteen) chu General Retail Licence nei tan chauhva luah theih ni se, Restricted Licence hian damdawi tihtham a huam loh avang leh, prescription drugs ngei pawh a huam loh avangin hospital canteen meuh luah tur chuan dan mitah a fel tawk lo nasa a ni.
3. Licence hi hmungik nei (*location-specific*)-a pek a ni a, *House No. leh Location Address* ziah thlap thin a ni. Chu hmun chu FDA Officer-ten an endik hnua SLA pawm a ni a, SLA phalna awm lovin hmun dangah sawn ngawt theih a ni lo. Chuvangin, canteen luah tur thlan fel a nih hnua licence neitu (*selected bidder*) chuan SLA ah hospital-a pharmacy sawn phalna a dil

4. ang a, SLA chuan Rule 62 of Drugs Rules, 1945 angin licence thar pekchhuah emaw, kawng remchang dangin emaw ruahmanna a siam thin ang.
5. Hospital pharmacy (*canteen*) luah hi term nei (kum 2 emaw chauh) a nih thin avangin, chumi chhung chauh valid tura licence thar pek hi fuh tawk lovin a lang a. Chuvangin, canteen luah chhung atana licence *temporary-a* hospital hmuna sawn chu a remchang zawk tura ngaih a ni. Hospital pharmacy enkawl (*operate*) a nih chhungin pharmacy hawnna hmasaah hawn theih a ni lo va, canteen chhuahsan hnuah chauh SLA phalnain hawn leh thei a ni ang.
6. Canteen kalphung tur dang chu hospital hotute ruahmanna siam dan ang apiang a ni ang a, a luahlu tur thlannaah FDA aiawh telhve theih a nih chuan a tha hle ang.


