GUIDELINES FOR ACCESSIBLE DCH/DCHC/CCC/CCCC/DCCC FOR PERSONS WITH DISABILITIES (PERMANENT/ TEMPORARY)

- Provision for the company of a care-taker where cases demand may be made available. In case the PwD is relatively independent as in the case of many blind PwDs, deaf/mute etc. such a provision may not be necessary.
- 2. Wheel-chair accessible covid wards and toilets maybe made available at DCH and at least in one designated CCC in all districts in Mizoram.

- 3. Even if there is only one toilet for the ward, the existing one may be converted to a universal design which is user friendly to differently abled persons.
- 4. The logistical services at the centres such as testing facilities, medical monitoring/treatment, nursing care, serving of meal etc. should be sensitive to the needs of the differently abled persons.
- 5. There should be provision of privacy in the form of portable screen/curtain etc. when the differently abled persons need to change clothes.
