NOTIFICATION

No. D.33011/21/2021-HFW(nCOV)/Pt.1: Whereas it is considered expedient to provide security to the Covid fighters in the event of their being infected with the Covid-19 virus:

- 2. Now, therefore, the Governor of Mizoram is pleased to hereby order, with immediate effect and until further order, that medical treatment as prescribed by guidelines in force for management of Covid patients, including dietary provisions for Covid patients as per standing norms of the Government of Mizoram, shall be given free of cost to any of person belonging to the categories listed below who are treated in any notified Covid Care facility or under Home Isolation, on account of their contracting of the Covid-19 disease while performing any duty related to the combat against Covid-19 such as, handling the swab samples or tending the Covid patients, or while performing duties to control the spread of the Covid-19:—
 - (a) Healthcare workers and staff, including Volunteers engaged for combating the Covid-19 by or under authorisation of the Health & Family Welfare Department, Government of Mizoram.
 - (b) Care-giver of Covid patients under Home Isolation.
 - (c) Members of Village Level Task Force/Local Level Task Force, including the volunteers appointed by the said Task Forces to strengthen the Task Forces concerned.
 - (d) Members of Covid Executive Duty engaged by the Deputy Commissioner.
- 3. The person concerned shall produce, at the time of admission in the Covid care facility, an authenticated copy of valid engagement card or appointment letter duly issued by the competent authority concerned, to the person in charge of such facility who will record the same in the Patients' Register and also on the Discharge Certificate when issued:

Provided that in case of the Care-giver of a home-isolated Covid-patient, a certification by the Covid patient or head of his/her family on the engagement of that person as Care-giver, countersigned by the Chairman of the VLTF/ LLTF shall be sufficient as proof of engagement.

4. The fact that the person has been infected with Covid-19 virus while performing the Covid-19 related duty shall be certified by leader of the Contact

Tracing Team or Surveillance Officer concerned, and the same shall be referred to while considering the case of free treatment.

5. If any person covered under this order is entitled to medical reimbursement or health insurance under any Rule or Scheme, the items provided free of cost as per this order shall be excluded in the claims for such reimbursements.
