CIRCULAR

National Ambulance Service leh JSSK chungchang.

1. Ambulance te hi mipui ta a nih avangin damlo phurh hi a tihtur pawimawh leh hmasa ber a ni a. Damlo/nau nei tur etc. phurh hi thildang M.O bial fan etc aia ngaih pawimawh hmasak thin tur a ni.
2. M.O in leave a lakin, damlo/nau nei tur etc. phurh tur an awm loh chuan ambulance in a thlah thei ang. Mahse, ambulance chu a post na PHC ah a let leh nghal tur a ni.
3. NRHM hnuaiia, District Hospital, CHC leh PHC-a National Ambulance Service (NAS) te chu JSSK Programme hnuaiyah Raipuar nau nei tur te, Nausen thla khat chin hnuailam damlo te, In atanga Govt Institutions pick up nan te, refer nan leh drop back nan hman vek tawh tur a ni.
4. Nu Naunei tur leh Nausen thlakhat hnuailam Ambulance a phurh te (Home to Institution pick up leh drop back te, referred te) chu free veka phurh tur an ni.
5. JSSK programme hnuaiia phurh nilo, case dang erawh chu hire tirin Rs 25/km rate anga phurh tur an ni ang.
6. Hire man hi Ambulance awmna Institution-ah register fel taka vawngin ziah luh vek hnuah RKS fund atan chhunluh tur a ni ang, heta tang hian a tul angin POL lak tur a ni ang.
7. Hire tu ten an hmanna man an pekna tur, Receipt bu siam tur a ni a, a hman man pe tur te receipt pek nghal zel tur an ni Hemi chungchangah hian Driver leh RKS enkawltu ten mawh an phur ang.
8. Ambulance tlanna reng reng, JSSK program emaw, thildang engpawh, Damdawiin duty thlah a tul a nih a, a chhuah pawhin, register ah driver in KM zat nen a ziak vek tur a ni. (Register a ziah dan tur chu a hnuaiyah tarlan a ni)
9. Register a inziak chu a lakkhawm (consolidate) dan a hnuaiia inziak ang hian thla tir ni hmasa berah ambulance driver in M.O incharge emaw, Med. Suptd hnenah emaw thehluh tur a ni a, anni hian CMO hnenah JSSK report pek rualin an thehlut ve thung ang. CMO in JSSK report format thar hmangin State ah a thehlut ang.
10. Ambulance maintain na leh JSSK atana senso POL etc te hi JSSK fund atanga hman a rem tawh dawn loh avangin JSSK hnuaiyah Ambulance hmanna POL man reng reng

chu JSSK form hmang hian Mission Director, NRHM ah thehluh tur a ni a, Mission flexipool atangin POL hi re-imburse a ni ang.

11. National Ambulance Service ho te hi GPS fit an ni a, hei hi Call Center atanga control vek an nih bak ah an awmna hmun leh an tlan zat Km te Call Centre atanga record vek an nih vangin Ambulance a GPS te hi uluk taka enkawl tur a ni. a chhe palh a nih chuan Call Centre-ah Report nghal tur a ni, Call Centre atanga Monitor theihloh / an tlan dan record theihloh Bill chu submit pawh nise, reimburse sak an ni lovang.
12. Ambulance remchanloh lai emaw, awmlohna hmunah chuan private Vehicle an hmang anih pawhin an hman man Receipt feltak siamin actual rate-a pek tur a ni, mahse approval rate thar ber angin Pick up nan Rs 400/- (Cheng Zali) leh Drop back nan Rs 400/ (Cheng zali) aiin a sang tur a ni lo.
13. Nu Nau nei te chu damdawiinah, normal delivery tan darkar 48 leh Caesarean Section tan ni 7 admit an nih loh chuan Drop back man pek emaw Ambulance a Drop theih an ni lo. Nausen damlo chu drop back zel tur an ni.
14. A hnuaia reporting format te hi July thla tir atangin District zawng zawngah hman tan vek tur a ni.

Hei hi He lehkha chhuah ni atanga thu leh awm hma chu hman nghal tur a ni ang.
