**SHORT TENDER NOTICE**

Sealed Tenders are hereby invited from reputed and bonafide Manufacturers (Attested Xerox copy of valid Manufacturing Licence duly approved by the Licencing Authority for the products quoted should be enclosed) of HCV Drugs covered under the Drugs & Cosmetics Act and possessing WHO-GMP certificate issued by the Licencing Authority viz.,

(1) Sofosbuvir 400mg + Daclatasvir 60 mg tab. of 28 tabs.

(2) Sofosbuvir 400 mg + Ledipasvir 90 mg tab. of 28 tabs.

for direct purchase by the empanelled Hospitals under Mizoram State Health Care Society **which will be valid for a period of six months**. The selected Manufacturers will also have to provide 2 (two) free HCV RNA quantitative test and one (1) free Genotype test to each HCV (+) Patient as well as 1 (one) Counselor (preferably Medical Background) support for the patients.

The bids will be received by the Chief Executive Officer, Mizoram State Health Care Society, Mizoram, Aizawl on or before **21<sup>st</sup> October, 2016 up to 12:30 pm** under the terms and conditions laid down below. Quotations are to be opened by Chief Executive Officer, Mizoram State Health Care Society, Mizoram, Aizawl or his authorized representatives at **1:00 pm** on the same day. The Tenderers or their representative may also be present at the time of opening of the Quotations, if they so desire.

**TERMS & CONDITIONS**

1. Bids must be submitted in the prescribed form only. Tender has been called for in the generic names and Bidders should quote the rates for the generic products.
2. Earnest Money amounting to ` 50,000/- (Rupees fifty thousand) in the form of Deposit at Call/ Fixed Deposit in original from any Nationalized Bank of India or Postal Saving Certificate duly pledged in favor of Chief Executive Officer, Mizoram State Health Care Society, Aizawl, must accompany such tender, if submitted.
3. The outer cover of the tender should be super scribed as “**Bid for HCV Drugs**” addressed to Chief Executive Officer, Mizoram State Health Care Society, Aizawl clearly indicating full postal address with Phone No. and e-mail address of the tenderer/sender.
4. A Non-tribal bidder should affix a Non- Judicial Adhesive Stamp worth of at least ` 7.50/- only and should furnish photostat copy of valid sales Tax/VAT Registration certificate or document upto the latest year for which assessment has been made by the concerned authority, and duly attested by a Gazette Officer or Notary. Original Certificate should be produced at the time of opening of the tenders/quotations, if demanded.
5. Manufacturers submitting their bids should attach photostat copies of their Manufacturing Licence, Drugs Licence, CIN (Corporate Identity Number) and other relevant permissions/licences required for such manufacturing, duly attested by a Gazette Officer or Notary. Original Certificates should be produced at the time of opening of the bids/quotations, if demanded.

6. All bids/quotations shall be accompanied by attested copy of valid Drugs Licence of the Bidder/Manufacturer for dealing with the drugs covered under Drugs & Cosmetics Act.
7. Bidder should have experience & knowledge of modes of packing, distribution & transportation of such items under any weather conditions.
8. A Bidder should quote his/her rates in terms of Indian Rupees inclusive of all taxes and duties.
9. The quality of the items supplied shall be of WHO standards. The successful bidder shall take back the drugs which are not utilized by the Society within the shelf life period.
10. It shall be the responsibility of the successful Bidder for any shortages/damage at the time of receipt.
11. The successful Bidder shall supply the product to reach the consignee/Hospital within 60 days from the date of manufacture of the drugs. In case the product is received after 90 days from the date of manufacture and the product is not consumed before its expiry date, the successful Bidder shall be permitted to replace the expired quantity with fresh stock of longer shelf life otherwise the expired product will be returned to the successful Bidder and the value equal to the cost of expired quantity will be recovered.
12. Bidder should quote their rates F.O.R destination.
13. All pages of the tender papers should be printed, signed, stamped and dated; hand written quotation shall not be entertained. Any page or pages not signed, stamped and dated are liable to be rejected. Correction, if any, should be initialed, stamped and dated.
14. The Bidder should submit Notorized Photostat copy of valid and up to date GMP and CoPP Certificates.
15. If any Bidder violates or fails to fulfill any one of the above mentioned requirements, his or her tender may be liable to be rejected at the time of opening of the tender.
16. Once the rate is accepted by the Society and communicated to the successful Bidder, the same shall remain valid through out the life of the agreement as may be executed in due course with the approved Bidder and no further price escalation will be allowed during such validity period which shall normally be a period of 12 months from the date of execution of the agreement and may be extended, if mutually agreed upon by both the parties i.e. the Mizoram State Health Care Society and the concerned Bidder.
17. A successful Bidder whose tender has been accepted will have to execute an appropriate Deed of Agreement within 15 (fifteen) days from the date of communication of acceptance of his/her quoted rate(s) by fax/e-mail, failing which their tender will be treated as invalid.
18. A successful Bidder will have to supply the materials tendered for, within the period fixed by **the Hospital** and specified in the agreement. If the supply cannot be made within the stipulated period without any valid and justifiable reasons with prior intimation, the Department shall be at liberty to procure the materials from the next lowest Bidder and the differences in prices, if any, will be realized from the Security Deposit of the successful and approved Bidder without assigning any reason thereof.
19. In the event of the samples of Drugs failing quality tests or found to be not 'intact' and complaints are received from the Hospitals, the Society is at liberty to make alternative purchase for which the purchase orders have been placed

from any other Bidder who might have quoted higher rates at the risk and the cost of the successful Bidder and in such cases the Society will have every right to recover the cost and impose penalty.

20. The Society shall not be bound to accept the lowest rate or any of the bids even if valid, and reserves the right to accept or reject any tender without assigning any reason thereof. The Society may give preference to supplier/firms of reputed brand/company and having good performance record.
21. In case of any legal dispute/litigations arising out of this Tender Notice or its terms, the local courts shall have the jurisdiction as per the relevant laws in force.
22. The Society will not take responsibility for supplying Road Permits.
23. Payments will be made only after the materials are received in full and in good condition to be certified by the Vigilance Committee of the Directorate and after completion of the installation satisfactorily, whatever it is required so. There shall not be any advance payment and no such request shall be entertained.
24. Any attempt for negotiation/campaign, direct or indirect, on the part of a Bidder with the authority to whom he has submitted the Tender or the authority who is competent to accept the same, shall render such Tender liable to be excluded from consideration, if it is so proved.
25. Belated/delayed tenders shall not be entertained in any case. Certificates other than those stated in the foregoing clauses shall be rejected straightaway. Any other/further clarifications in connection with submission of tender mentioned herein may be made from the office of the Chief Executive Officer, Mizoram State Health Care Society, Aizawl during office hours on all working days.
26. The acceptance of the tenders will be communicated to the successful bidders in writing.
